87.375504, W9 (0.02 acre) located at 33.819210, -87.377332, and W10 (0.08 acre) located at 33.819309, -87.384492. These wetlands were created during pre-SMCRA surface coal mining at the site. Each of the wetlands are geographically isolated with no hydrologic connection to a water of the U.S. Rationale: W2 is approximately 1000 feet to the closest RPW and is not located within the 100 year floodplain. W9 is approximately 200 feet to the closest RPW; however, W9 sits in a "bowl" and is separated from the closest RPW by a rise in elevation. It is not located within the 100 year floodplain. W10 is approximately 550 feet from Lost Creek and is not located within the 100 year floodplain.

W2, W9, and W10 have no nexus to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shell fish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce.

For all of these reasons, W2, W9, and W10 are not jurisdictional waters of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
