B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, and historic aerial photography, the project area consists of upland/non-wetland, dry lands. Aerial photography shows the area that would be impacted by the proposed water treatment plant development to be located in Biggersville, Alcorn County, Mississippi, is a selectively cleared and maintained dry land area that appears to have historically been part of residential homestead land and/or agricultural and pasture land. Desktop resources evaluated also indicate the site lacks any streams or tributary features
