**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands given the requirements that all work is constructed above the Ordinary High Water of Sowashee Creek. Aerial photography shows the area that would be impacted by the proposed bulkhead to be located within the Atlas Roofing Corporation property in Lauderdale County, which is a maintained dry land area. Desktop resources evaluated also indicate the JD review area lacks any streams or tributary features.
