B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the area that would be impacted by the proposed flow meter installation at lift station 3 (LS-3) which is near South Raymond Avenue South in Lee County, which is a dry land area. Desktop resources evaluated also indicate the JD review area lacks any streams or tributary features.
