**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the area that would be impacted by the proposed sanitary sewer replacement and repairs within the development of the U.S. Post office at the intersection of Raymond Avenue South and Carey Drive in Lee County, which is a dry land area. Desktop resources evaluated also indicate the JD review area lacks any streams or tributary features.
