- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Four wetlands identified as WA (0.677 acre; 32.688263, -86.549877), WF (0.836 acre; 32.689870, -86.552860), WH (0.136 acre; 32.682598, -86.554765), and WI (0.208 acre; 32.683293, -86.557039) are within the review area. These wetlands are geographically isolated with no downstream connection to a water of the U.S. WA sits in a depressional area north of the access road. There is no culvert under the road or evidence of flow going from the wetland downgradient. WF is approximately 800 feet to the nearest stream, an ephemeral stream, with no connection to that tributary. WH is in a depression and is 1,500 feet to the nearest tributary. WI is 1,400 feet to the nearest tributary. The wetlands are not located in the 100 year floodplain. They have no nexus to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. For these reasons, WA, WF, WH and WI are not jurisdictional waters of the U.S .**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
