USGS topographic mapping, USFWS wetland mapping, aerial photography, and site plan drawings, the JD and project review area consists of 5.18 acres of upland/non-wetland, dry lands. Evaluated desktop resources and information provided by Geotechnical and Environmental Consultants, Inc. (GEC) indicate no wetlands, streams, or tributary features within the 5.18-acre JD review area in which the construction of a picnic pavilion, gazebo, and outdoor fitness activity area will occur.
