**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the identified 11.74-acre review parcel to consist of an undeveloped, forested dry land area west of North Airport Road and north of Old U.S. Highway 78 in Walker County. Desktop resources evaluated also indicate the defined JD review area lacks any streams or tributary features.
