**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the JD review area to be an undeveloped, forested 7-acre upland/dry land parcel west of Medical Center Drive in Jasper, Walker County. Desktop resources evaluated also indicate the JD review area lacks any streams or tributary features.
