B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE

REVIEW AREA ONLY INCLUDES DRY LAND: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, and aerial photography, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the specified review area that would be impacted by the proposed development to be located within EL Turner Park in Crenshaw County, is a maintained dry land area. Desktop resources evaluated indicate the JD review area lies in close proximity to Beaver Creek; however, the stream feature lies outside of the project area. No additional stream and/or tributary features occur near or within the project boundary.
