- C. Additional comments to support AJD: A desktop review was performed for the subject property on July 09, 2020. The desktop review of the subject property included assessments of USDA Web Soil Survey data, aerial photographic imagery, the USFWS National Wetlands Inventory map, and USGS 7.5 Minute topographic maps. The reviewed resources are saved in the Administrative Record for this project. The project will occur entirely within an existing pump station facility. A desktop survey indicates no wetland

characteristics within the facility. The agent has confirmed that any ground disturbance is anticipated to occur within the existing facility footprint and will not be substantial. The agent confirmed by email dated June 29, 2020, that should any change to the project footprint that may potentially fall within jurisdictional areas, the design engineer would coordinate with our office. Based on review of the above mentioned resources, it has been determined that Department of the Army (DA) permit authorization is not necessary, because the project does not involve activities in, over, or under navigable waters of the United States regulated under Section 10 of the Rivers and Harbors Act (33 U.S.C. 403) or the deposition of fill material, permanent or temporary, in waters of the United States, including wetlands, regulated under Section 404 of the Clean Water Act (33 U.S.C. 1344).

Based on the above review, facility improvement project by the Board of Water and Sewer Commissioners of Mobile should not affect any jurisdictional waters of the United States, and a DA permit will not be required.
