C. Additional comments to support AJD: [The wetland at the site is part of a larger bowl like forested wetland comprised of red maple, sweet bay and gums. The site holds water as evidence of water stained leaves and water marks on trees. However, I could not find a connection \(natural or man-made\) to any other waters that would connect it to TNWs. It is likely, that through the years, surrounding development may have cut off this wetland feature from waters of the U.S.](#)

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
