Wetland 1	0.16	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 1 is a depressional Grady pond lacking a surface hydrologic connection to an (a)(1)-(a)(4) jurisdictional water.
Wetland 2	0.53	acre(s)	(b)(1) Non-adjacent wetland	Although Wetland 2 contains two manmade ditch features, providing a surface connection to the nearby intermittent tributary of Bon Secour River, a ditch cannot render an otherwise isolated wetland an “adjacent wetland” and thus jurisdictional on that basis, unless the ditch itself is a tributary. Because these features do not act as a tributary, the wetland is considered non-jurisdictional.
