II. FINDINGS

- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The proposed water main will be installed entirely within the previously disturbed and filled Highway 98 right-of-way (ROW). This ROW is comprised of upland roadway fill material. A stream crossing is located within the northern section of the review area, however, the proposed new water main pipeline will be installed above an existing culvert within previously disturbed ROW. The review area includes approximately 1,900 linear feet of proposed water main installation outside of the existing ROW in the southern area of the project. Soils along this 1,900 linear feet of review area exhibit non-hydric profiles indicative of sandy marine deposits derived from sedimentary rock. Primary soils within this southern section include: Orangeburg (90%), Lakeland 85%, Norfolk 90%, and Eustis loamy fine sands (85%). Further, the review area is located within a FEMA area of minimal flood hazard Zone X.
