B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the areas that would be impacted by the proposed water line installation along existing roadways in Tallapoosa County, consists of maintained dry land areas. Desktop resources evaluated also indicate the JD review area lacks any streams or tributary features.
