C. Additional comments to support AJD: [Desktop review indicates the review area consists of roadway ROW and disturbed non-hydric soils. Soils within the review area include: Bama fine sandy loam well drained soil series; and Smithdale fine-loamy well drained soil series, neither of which support hydric vegetation. The review area is within a FEMA Zone X area of minimal flood hazard. Work, as proposed, will occur entirely within non-jurisdictional uplands and roadway ROW.](#)
