C. Additional comments to support AJD: The wetland at the site is part of a larger forested wetland comprised of titi, sweet bay, wax myrtle, slash pine, and gums. This wetland abuts a(2) tributary which veers south under the rail road via culverts into the same wetland system and connects to Turkey Creek and then connects to a TNW.
