The subject feature is a manmade ditch with ephemeral flow that can be observed within a terraced agricultural plot in historic aerial imagery dating back to 1957. Data sheets submitted with the request indicate the feature abuts uplands and drains to wetlands located off-site to the south, identified by U.S. FWS NWI Mapper. The nearest (a)(2) feature is an intermittent tributary of Cypress Creek, measured to be 0.17 miles south of the subject feature.
