- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: NEW WELL SITE JD: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, and aerial photography, the JD review area for new well installation consists of upland/non-wetland, dry lands. Aerial photography shows the area at the intersection of Toles Road and County Road 39 that would be impacted by the proposed well construction in Kemper County is a maintained dry land area adjacent to existing developed and maintained upland land. Desktop resources evaluated also indicate the well installation JD review area is located near the crest of a hill and lacks any streams or tributary features.
