- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Based on review of the agent's delineation report (Wildland Services, LLC) and available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the 5.2-acre area that would be impacted by the proposed work in Lee County is a dry land area consisting primarily of previously developed residential areas and maintained pasture/fields. Desktop resources evaluated also indicate the JD review area lacks perennial or intermittent tributaries or associated wetlands.
