- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the 2,500-square-foot JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the area that would be impacted by the proposed lift station at the corner of Honda Drive and U.S. Highway 78 in Talladega County is a dry land area which was previously developed with a small commercial structure and gravel driveway. Desktop resources evaluated also indicate the JD review area lacks perennial or intermittent tributaries or associated wetlands.
