- **B.** Typical year assessment(s): The APT for 9/21/2020, the date of the agent's site visit, indicates it was the dry season and the area was experiencing wetter than normal conditions, which helps justify the ephemeral flow regime for EFB and EFC, which were dry during the site visit. The APT for 4/22/2021, the date of the Corps project manager's site visit, indicates it was the wet season and drier than normal conditions. This helps justify the intermittent flow regime of the upper reach of SFCi, which had some flow in the channel and pooling along the reach.
