- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The features discussed are situated within a larger approximately 885 acres that is located on the east and west sides of Interstate 65 (I-65) and south of Tyson Road in Letohatchee, Lowndes County, Alabama. Approximately 685 acres of the site are on the west side of I-65 and 200 acres are on the east side of the interstate. The jurisdictional determinations covered by this AJD are limited to the features discussed herein. USACE staff conducted an onsite pedestrian survey of the property. During this investigation staff accessed areas upslope and downslope of the features in question and did not locate any visible surface connections to potentially jurisdictional waters. Wetlands H and F (i.e., 0.14 acre at 32.182462, -86.431104 and 0.1 acre at 32.180599, -86.44074, respectively) are located on the western portion of the property and were both observed to be isolated areas without any observable connection to other jurisdictional waters. Both areas are depressions in open fields (cattle pasture) that appear to have been created for livestock use. Wetlands H and F exhibited hydrology, vegetation, and soils consistent with wetland characteristics. No linear features were observed leading away from the depressions indicating these areas do not drain into additional features. The closest potentially jurisdictional feature to W-H is a wetland approximately 210 linear feet (LF) to the west (Heading 278.7°). The closest feature to W-F is an intermittent tributary approximately 150 LF to the north (Heading 25.4°). Both wetlands W-H and W-F are situated outside the 500-year (0.2% return interval) floodplain and are geographically isolated from any tributaries.

In addition to the two previously discussed wetland areas, a cluster of five aquatic resources -situated in a northwest to southeast orientation- on the eastern portion of the property were determined to be geographically isolated. Linear features (ephemeral) S-P (32.19252, -86.416011), S-9 (32.191027, -86.415251) and S-10 (32.191085, -86.41468), wetland W-5 (32.1917, -86.41566), and open water feature OW-2 (32.191802, -86.415078) are connected to one another; however, they do not have an observable surface connection to any jurisdictional aquatic resource features. More specifically, linear feature S-P, flows 657 LF to the southeast before discharging into a 0.3 acre palustrine forested wetland (W5), which is situated along the western boundary of Open Water -2 (OW-2). OW-2 (1.75 acres) is an impoundment created by a man-made dam. The discharge point for OW-2 is on the southwestern corner of the pond. Water draining from OW-2 formed ephemeral channel S-9, which extends 562 LF to the southeast from the southwestern corner of OW-2. Ephemeral stream, S-10, originates in a wooded area just south of OW-2 and extends slightly southwest for 146 LF before joining S-9 -approximately halfway down the length of S-9- to become S-9. Approximately 562 LF from its origin below OW-2, S-9 enters an area of hard clay where bed and bank features are not observable, there are no other indicators of an ordinary high-water mark, and the landscape becomes an upland farmland with no drainage patterns evident. The termination of S-9 marks the downstream extent of the cluster of aquatic resources. The closest jurisdictional feature to the termination point is a perennial tributary approximately 440 LF south (Heading 180°).

These wetlands and waters do not support a link to interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. These wetlands and waters were determined to not be a WOTUS and not to be jurisdictional under the CWA..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
