	acre review area as shown within a red border on aerial maps provided by the agent, Northstar
	Engineering Services, Inc The parcel is cleared, low intensity commercial land use, and is located on
	a raised, upland elevation zone approximately 500 feet south of nearest waterbody (Little Piney Woods
	Creek). The northern end of the parcel is bordered by oak (Quercus spp.) and pine (Pinus spp.) tree
	species. The review area is comprised entirely of uplands with no jurisdictional waters within; no hydric
	soils are present within the site with the primary soil profiles composed of non-hydric Faceville sandy
	loams and Faceville-Nankin complex.
