The subject feature is a water-filled depression which only receives hydrologic input from precipitation, groundwater, and runoff from adjacent uplands and manmade ditches. Although a tributary is visibly approximately 1,000 feet to the west of this pond on some topographic maps of the area, only ditches connect those waters to this manmade pond and thus cannot render an otherwise isolated pond a jurisdictional water. Furthermore, historic aerials (1997) indicate this pond was once uplands. In accordance with the NWPR, manmade nontidal drainage excavated on dry land are not considered waters of the United States.
