W-21 is a .40 acre depressional wetland feature located adjacent to existing railroad tracks that was determined to have no hydrologic or ecological connection to a surface tributary system. The feature is approximately 550 feet West of Springfield Creek and is severed to the South by an existing railroad. It is geographically isolated from a TNW or RPW. There is not a culvert connecting it to any wetlands or RPW on the opposite side of the railroad tracks. There is not surface or subsurface connection to a TNW or RPW. Whereas, the isolated wetland area is a depression underlain by silty clay (Vaiden series), poorly drained and slowly permeable soils. Based on landscape position and soil characteristics (water table at or near the surface six to eight months per year) wetland hydrology would likely be supplied via groundwater and supplemented by precipitation. W-21 is not known to support interstate or foreign commerce. It is not known to be used by interstate or foreign travelers for recreation or other purposes. W-21 does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce or used for industrial purposes by industries in interstate commerce. For all of these reasons, W-21 does not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a) and is not jurisdictional under the Clean Water Act.

W-30 is .27 acre isolated depressional wetland feature that was determined to have no hydrologic or ecological connection to a surface tributary system. The feature is approximately 300 feet North of Chickasaw Bogue. It is geographically isolated from a TNW or RPW. There is not a culvert connecting it to the RPW. There is not surface or subsurface connection to a TNW or RPW. Whereas, the isolated wetland area is a depression underlain by clayey (Sucarnoochee series), poorly drained soils. Based on landscape position and soil characteristics (water table at or near the surface six to eight months per year) wetland hydrology would likely be supplied via groundwater and supplemented by precipitation. W-30 is not known to support interstate or foreign commerce. It is not known to be used by interstate or foreign travelers for recreation or other purposes. W-30 does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce or used for industrial purposes by industries in interstate commerce. For all of these reasons, W-30 does not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a) and is not jurisdictional under the Clean Water Act.

W-32 is .89 acre isolated depressional wetland feature that was determined to have no hydrologic or ecological connection to a surface tributary system. The feature is approximately 465 feet West of Whirl Creek. It is geographically isolated from a TNW or RPW. There is not a culvert connecting it to the RPW. There is not surface or subsurface connection to a TNW or RPW. Whereas, the isolated wetland area is a depression underlain by clayey (Tuscumbia (~87%) and Sucarnoochee (~13%) series), poorly drained and slowly permeable soils. Based on landscape position and soil characteristics (water table at or near the surface six to eight months per year) wetland hydrology would likely be supplied via groundwater and supplemented by precipitation. W-32 is not known to support interstate or foreign commerce. It is not known to be used by interstate or foreign travelers for recreation or other purposes. W-32 does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce or used for industrial purposes by industries in interstate commerce. For all of these reasons, W-32 does not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a) and is not jurisdictional under the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
