- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Based on review of available desktop resources including Web Soil Survey mapping, USGS topographic mapping, aerial photography, and current site-specific photos, the approximately 0.1-acre JD review area consists of upland/non-wetland, dry lands. Aerial photography shows the area that would be impacted by the proposed abandoned mine reclamation in Walker County is a dry land area which was historically mined and is currently part of a residential area. Desktop resources evaluated also indicate the JD review area lacks perennial or intermittent tributaries or associated wetlands.
