Explain: **Review Area is approximately 12 acres and contains a 0.2-acre isolated, non-jurisdictional wetland located near the center of the subject parcel adjacent to Dauphin Island Parkway. Soils in the review area were historically**

mapped as Harleston (moderately well-drained, non-hydric) with Smithton and Bibb (poorly drained, hydric) components. The area has been extensively modified as a result of a regular logging and surrounding construction of a neighborhood to the north and Dauphin Island Parkway to the east. Historic records are limited, but the review area wetland appears to have been previously connected to Mobile Bay via a tributary that has since been ditched and redirected around this property in conjunction with neighborhood development to the north that occurred between 1955 and 1967. Some jurisdictional wetlands are present on site, as verified through a PJD issued October 7, 2021 in conjunction with a permit for fill. The jurisdictional wetland maintains a surface connection to receiving waters through a tributary that is culverted beneath Dauphin Island Parkway. However, the review area's depressional wetland is topographically separated from the jurisdictional portion of the review area and is surrounded by non-hydric soils and non-wetland vegetation. During a field review on October 27, 2021, the USACE, Mobile District did not document any ditches or culverts that would provide direct surface connection to wetlands or waters adjacent to Mobile Bay. The USACE noted tracks due to heavy machinery throughout the upland portions of the review area, indicating the wetland depression is likely a result of frequent earth moving for timber harvesting that began to exhibit wetland characteristics over the years. As such, there is no evidence of any appreciable surface water connection between the review area wetland and the receiving TNW. Therefore, the subject wetland was determined to be isolated and does not have a significant nexus with the downstream TNW.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The subject wetland is isolated from downstream waters, as documented onsite by USACE. Total linear distance from the review area wetland to the nearest TNW is approximately 0.62 miles. There is no evidence of a continuous surface connection between the review area wetland and jurisdictional waters of the United States sufficient to meet the Significant Nexus standard.**
