is a 0.4 acre forested wetland located at 33.131859, -87.579799; W-14 is a 0.063 acre forested wetland located at 33.131955, -87.578597; W-16 is a 0.083 acre forested wetland located at 33.129507, -87.581409; W-18 is a 0.001 acre forested wetland located at 33.133289, -87.578244; and W-19 is a 0.008 acre emergent wetland located at 33.131844, -87.577255. W-10, W-11, W-12, W-13, W-14, W-16, W-18 and W-19 are all depressions that are geographically and hydrographically isolated from a downstream RPW. There is no evidence of drainage or connection from the wetlands to downstream waters. W-10, W-11, W-12, W-13, W-14, W-16, W-18 and W-19 do not support a link to interstate or foreign commerce. They are not known to support interstate or foreign commerce. They are not known to be used by interstate or foreign travelers for recreation or other purposes. They do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, or used for industrial purposes by industries in interstate commerce. For all of these reasons, W-10, W-11, W-12, W-13, W-14, W-16, W-18 and W-19 do not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a) and are not jurisdictional under the Clean Water Act.

OW-1 is an active dredge pond, of which 1.3 acres is within this review area, and is located at 33.146915, -87.576793. Pursuant to the preamble to the final 33 CFR Part 328 (51 FR 41206 November 13, 1986) these types of waters are not considered to be waters of the US. See preamble 328.3 Definitions (e), which states the Corps generally does not consider the following water to be waters of the U.S. : "Waterfilled depressions created in dryland incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States (see 33 CFR 328.3(a))." OW-1 was created in uplands for the purpose of obtaining sand and gravel. This waterbody does not support a link to interstate or foreign commerce. It is not known to be used by interstate or foreign travelers for recreation or other purposes. It does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and are not known to be used for industrial purposes by industries in interstate commerce. For all of these reasons, OW-1 does not meet the definition of waters of the U.S. as defined by 33 CFR Part 328.3(a).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
