desktop review. The subject parcels have historically been used for silviculture, and the topography has been modified over the years due to repeated land clearing and the construction of temporary roads for timber harvest. While some stream features and wetlands were identified on the property in other locations as noted in a PJD issued in conjunction with a NWP on August 9, 2022, there is no evidence of any bed and bank, or of any seasonal or continuous flow within Streams B or D either through aerial imagery or photographs submitted by the agent. USACE did not observe any evidence of conveyance of regulated waters and noted only evidence of over land sheet flow which percolates through the soil. Review area Streams B and D are not located within a floodplain.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
