- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Wetland I is a 0.56-acre geographically isolated, forested wetland located at Latitude 33.1933, Longitude -86.8125. The wetland is situated in a low-lying area at the bottom of a few small hills in the north-central part of the JD review area. The nearest RPW is an unnamed tributary to Spring Creek located approximately 1,175 feet east of the wetland. There is no known information to show that Wetland I supports interstate or foreign commerce. There is also no known information to suggest that Wetland I is or may be used by interstate or foreign travelers for recreation or other purposes; produces fish or shellfish that could be taken and sold in interstate or foreign commerce; or is used for industrial purposes by industries in interstate or foreign commerce. Based on the above information, Wetland I does not meet the definition of waters of the U.S. as defined in 33 CFR 328.3(a)(3) and is not jurisdictional under the Clean Water Act.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
