**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** installing new water lines along portions of Madison Road, Magnolia Avenue, Washington High, Venus Street, Victoria Street, West Frontage Road, Longino Street and HWY 184, in the City of Collins, Covington County, Mississippi. According to the Engineer, all of the proposed work for water line installation will take place either in the existing roadway or in the existing mowed street right-of-way. No wetlands are located in the proposed mowed work areas. (The delineation provided by the applicant did not include a review of any existing areas beyond the mowed portion of the ROW. Additional information would be needed for review of jurisdiction of any areas outside of the mowed ROW as of the date of this letter.)
