Reference is made to your jurisdictional determination request dated March 28, 2022, on behalf of the Stone County School District regarding the proposed Stone County CTE Building. The project would be located on a 16.7-acre site near Woodland Drive in Wiggins, Stone County, Mississippi at Latitude 30.837650 North, and Longitude -89.143347 West. The proposed project has been assigned file number SAM-2022-00222-CSP which should be referred to in all future correspondence with this office.

Based on our review of the information furnished and information available to our office, we have determined the 16.7-acre parcel does not contain jurisdictional waters of the U.S. Based upon criteria contained in the USACE 1987 Wetland Delineation Manual and the Regional Supplement to the Corps Wetland Delineation Manual: Atlantic and Gulf Coastal Plain Region (Version 2.0), the parcel is comprised entirely of non-wetlands. Therefore, Department of the Army authorization pursuant to Section 404 of the Clean Water Act of 1977 (33 U.S.C. 1344) is not required for construction of the CTE Building at the location listed in the above paragraph and detailed in the attached letter/maps/drawings in Wiggins, Stone County, Mississippi. You should obtain a separate jurisdictional determination prior to conducting work in any areas outside the 16.7-acre subject parcel.

This letter contains an Approved JD for your subject site. If you object to this determination, you may request an administrative appeal under USACE regulations at 33 CFR Part 331. Enclosed you will find a Notification of Appeal Process (NAP) fact sheet and Request for Appeal (RFA) form. If you request to appeal this determination you must submit a completed RFA form to the South Atlantic Division Office, Regulatory Appeals Review Officer, South Atlantic Division, 60 Forsyth Street Southwest, Room 10M15, Atlanta, Georgia 30303-8801, (404) 562-5137, Fax (404) 562-5138.

In order for an RFA form to be accepted by the USACE, the USACE must determine that it is complete, that it meets the criteria for appeal under 33 CFR Part 331.5, and that it has been received by the District Office within 60 days of the date of the NAP. Should you decide to submit an RFA form, it must be received at the above address by June 27, 2022.

It is not necessary to submit an RFA form to the Division Office if you do not object to the determination in this letter.

This Approved JD is based on current policy and regulation and is valid for a period of five years from the date of this letter. If after the five-year period this JD has not been specifically revalidated by the U.S. Army Corps of Engineers (USACE), it shall automatically expire.

Nothing in this letter shall be construed as excusing you from compliance with other federal, state, or local statutes, ordinances, or regulations which may affect this work. Revisions to your proposal may invalidate this authorization. In the event changes to this project are contemplated, it is recommended that you coordinate with us prior to proceeding with the work.

If the scope of work or project location changes, as of the date of this letter, you are urged to contact this office for a verification of this determination. Thank you for your cooperation with our permit program.
