## MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),<sup>1</sup> SAM-2022-00760-AKG; MFR #1 of #1<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell quidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 3. REVIEW AREA. The review area is a linear transportation project with approximately 115 acres of right-of-way, located in Gadsden, Etowah County, Alabama. The center of the review area is latitude 33.999072, longitude -85.980901 and is located in the Middle Coosa 8-digit hydrologic unit code (HUC 03150106). The attached figures depict the review area.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW to which the jurisdictional aquatic resources are connected is the Coosa River. The Coosa River is on the Mobile District's Section 10 list beginning at river mile 170 approximately four miles south of the project review area. The Coosa River originates at the confluence of the Oostanaula and Etowah rivers in Rome, Georgia, and flows for 280 miles to the Alabama River. The Coosa River is an interstate water originating in Georgia and crossing the state line

into Alabama just east of Cedar Bluff. Ephemeral Stream 1 and Ditch 1 are not connected to a TNW, interstate water or territorial seas.<sup>6</sup>

## 8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

Ditch 1 is a non-tidal roadway drainage ditch that is approximately 600 feet long within the review area. Ditch 1 is centrally located at 33.997740°, -85.994782°. This ditch was dug in uplands during historic roadway construction, it drains only uplands, and carries less than a relatively permanent flow of water. The ditch is routinely maintained and has taken on characteristics of a linear stormwater pond and lacks an ordinary high water mark. For these reasons, Ditch 1 is not jurisdictional. Ditch 1 is depicted on the attached figures.

resource or feature, and how it was determined to be an "isolated water" in accordance with SWANCC. N/A

f. E1 is an approximately 112 linear foot ephemeral stream that only flows in response to precipitation events. E1 displays non-relatively permanent flow in response to precipitation throughout its length.
