B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE

REVIEW AREA ONLY INCLUDES DRY LAND: Based on review of available desktop resources including Web Soil Survey mapping, topographic mapping, and historic aerial photography, the review area consists of approximately 0.11-acres of existing developed upland/non-wetlands, dry lands within Michael Tucker Park. Aerial a photography review and project description shows the area that would be impacted by the proposed bathroom demolition and reconstruction is existing developed and maintained upland land. The review area lacks any wetlands, tributaries, or drainage features.
