B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE

REVIEW AREA ONLY INCLUDES DRY LAND: Based on review of available desktop resources including Web Soil Survey mapping, topographic mapping, FEMA flood insurance rate mapping, National Hydrography Dataset mapping, and aerial photography, the review area consists of an approximately 0.20-acre area of upland/non-wetlands, dry land that consists of an existing fenced pump station yard (approx. 0.10-acre) and access drive (approx. 0.10-acre). It is observable from review of aerial photographs and other desktop mapping resources that the 0.20-acre review area is a maintained utility station and does not contain any wetlands, tributaries, or drainage features.
