MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SAM-2023-00470-SNR, MFR #1 of #1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 3. REVIEW AREA. The review area includes an 18-acre undeveloped parcel located in Cottondale, Tuscaloosa County, Alabama. The site is centered at latitude 33.16596, longitude -87.39835.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW to which Wetland 1 is connected is the Black Warrior River, which is on the Mobile District's Section 10 waters list.⁶

⁶ This MFR should not be used to complete a new stand-alone TNW determination. A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

The water from Wetland 1 flows downstream via a culvert into a retention pond located just outside of the review area to the southwest. A standpipe in the pond allows the water from the retention pond to flow into a ponded area adjacent to Wire Road (County Road 14). Three corrugated metal pipes under Wire Road take the water from the pond into an unnamed tributary to Willow Swamp Creek, a relatively permanent water (RPW). The UT converges with Willow Swamp Creek approximately 1300 feet downstream. Willow Swamp Creek flows approximately 6,000 linear feet and converges with Mothers Branch to form Cottondale Creek. Cottondale Creek flows approximately 6 miles until it converges with Hurricane Creek, which flows approximately 7 miles to its convergence with the Black Warrior River (TNW).

Adjacent wetlands (a)(7): Wetland 1 is a 0.93-acre scrub shrub wetland located at approximate latitude 33.166560, longitude -87.400256 and has a continuous surface connection with a relatively permanent tributary located outside the review area to the southwest. Refer to Figure 4 for depiction of flow path. The water from Wetland 1 exits the review area via a culvert to a retention pond located just outside of the review area to the southwest. A standpipe in the pond allows the water from the retention pond to flow into a ponded area adjacent to Wire Road. Three corrugated metal pipes under Wire Road take the water from the pond into an unnamed tributary to Willow Swamp Creek, a relatively permanent water (RPW). The culverts and standpipe are discrete conveyances that provide a continuous surface connection from Wetland 1 to the unnamed tributary to Willow Swamp Creek, located approximately 420 feet to the southwest of the downgradient end of Wetland 1.



Wetland 2 is a 0.12-acre forested wetland located on a slope at approximate latitude 33.165621, longitude -87.399467. Although this wetland is located on a slope, there is no continuous surface connection to an RPW, TNW, territorial seas, interstate water or jurisdictional impoundment. The water table appears to be high at this location, but there is no stream or other discrete conveyance downgradient of the wetland. Uplands are present downgradient of this wetland as shown in Photo 1 of the Photolog. Wetland 2 does not meet the definition of a jurisdictional wetland because it does not have a continuous surface connection to a jurisdictional water.
