MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SAM-2023-01102-JDC; MFR #1 of #1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Alabama due to litigation.

3. REVIEW AREA. The review area for this AJD is limited to the feature identified as ES-1 and is situated within an 11-acre tract of land located in the northwest corner of the U.S. Interstate 22 and Industrial Parkway intersection in Jasper, Walker County, Alabama, at Latitude 33.796689, Longitude -87.241030. The attached figures depict the review area. The other aquatic resources within the project boundary will be documented on a preliminary jurisdictional determination form.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW to which ES-1 is connected is Cane Creek. Cane Creek is on the Mobile District’s Section 10 list and is a large tributary to Mulberry

Fork, which converges with Locust Fork to form the headwaters of the Black Warrior River.⁶

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

After precipitation events, ES-1 directs flow southeast beyond the southern boundary of the review area for 0.04 mile before flowing into relatively permanent water (RPW) IS-1. IS-1 continues flowing south for 0.01 mile before entering a culvert inlet in the westbound right of way (ROW) of U.S. Highway 22. IS-1 is piped under the interstate diamond interchange for 0.34 mile and exits the culvert in the eastbound ROW of Whitehouse Road. IS-1 flows southeast for 0.43 miles before draining into Cane Creek. Cane Creek meanders southeast for 4.9 miles until it becomes a Section 10 water as it falls below the normal pool elevation of the Corps' Bankhead Lake.

ES-1 is a non-relatively permanent water. Although a short segment of ES-1 (along the southern edge of the review area) had characteristics of relatively permanent flow including base flow and sediment sorting, the majority of the tributary had characteristics of non-relatively permanent flow such as a lack of baseflow, lack of soil-based evidence of a high water table, weak sinuosity along the thalweg, rooted upland plants in the streambed, leaf litter in the channel, and fibrous roots in the streambed. Based on the results of the Antecedent Precipitation Tool, site conditions were normal at the time of the Corps site visit on February 1, 2024; as a result, it appears that most of the feature only flows in response to rainfall events. ES-1 is 554.28 feet long and centered at latitude 33.796143, longitude -87.240977.






Topographic Vicinity Map
