MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SAM-2024-00272-JDC; MFR #1 of #1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in Alabama due to litigation.

- 3. REVIEW AREA. The review area for this AJD is limited to the features identified as Ephemeral 1 and Ephemeral 2 and is situated within a 56-acre tract of land located at the Vulcan Materials Company Glencoe Mine south of Main Street East in Glencoe, Etowah County, Alabama, at Latitude 33.939600, Longitude -85.927100. The attached figures depict the review area.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW to which Ephemeral 1 and Ephemeral 2 are connected is the Coosa River. The Coosa River is on the Mobile District's Section 10

list. Additionally, the Coosa River converges with the Tallapoosa River to form the headwaters of the Alabama River.⁶

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

After precipitation events, Ephemeral 1 directs flow east beyond the eastern boundary of the review area for 0.2 mile before joining Ephemeral 2 to form a second order tributary.

After precipitation events, Ephemeral 2 directs flow southeast beyond the eastern boundary of the review area for 0.22 mile before joining Ephemeral 1 to form a second order tributary.

The second order tributary continues flowing southeast for 0.7 mile before entering a culvert inlet in the southbound right of way (ROW) of U.S. Highway 431. The tributary is piped under the highway for 0.02 mile and exits the culvert in the northbound ROW of U.S. Highway 431. The tributary continues flowing east for 0.03 mile before it turns south, flows for 0.08 mile, converges with another stream, and enters a culvert inlet in the southbound ROW of an unnamed road. The tributary is piped for 0.01 mile, exits the culvert, and flows 0.02 mile into another culvert in the ROW of a Louisville and Nashville (L&N) rail line. The tributary is piped under the rail line for 0.02 mile, exits the culvert and flows 0.18 mile northeast before draining into another tributary, which flows 1.8 miles northwest into Little Cove Creek. Little Cove Creek flows 4.8 miles north into Big Cove Creek, and Big Cove Creek flows 1.2 miles north into the Coosa River.

Ephemeral 1 is a non-relatively permanent water. No flow was observed during the field visit. Based on the results of the Antecedent Precipitation Tool, precipitation was normal during the field visit, although the APT indicates the area was experiencing mild drought. Based on observed stream characteristics, including a lack of soil-based evidence of a high water table, weak sinuosity along the thalweg, rooted upland plants in the streambed, and leaf litter in the channel, this feature only flows in response to rainfall events and does not have continuous flow at least seasonally. Ephemeral 1 is 349 feet long and centered at latitude 33.9370, longitude -85.9260.

Ephemeral 2 is a non-relatively permanent water. No flow was observed during the field visit. Based on the results of the Antecedent Precipitation Tool, precipitation was normal during the field visit, although the APT indicates the area was experiencing mild drought. Based on the observed stream characteristics, including a lack of soil-based evidence of a high water table,

weak sinuosity along the thalweg, rooted upland plants in the streambed, and leaf litter in the channel, this feature only flows in response to rainfall events and does not have continuous flow at least seasonally. Ephemeral 2 is 131 feet long and centered at latitude 33.9387, longitude -85.9259.


