MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 598 U.S. 651 (2023),¹ SAM-2024-00326-JEB, MFR #1 of #1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 1. SUMMARY OF CONCLUSIONS.

Linear Wetland, a 0.83-acre wetland area located on an undeveloped parcel in Foley, AL. This wetland does not have a continuous surface connection to a jurisdictional water and it is therefore not a water of the United States.

- 3. REVIEW AREA. The review area is a 0.83-acre portion of a larger 21.54-acre undeveloped parcel. This 0.83-acre wetland area features soils, hydrology and vegetation consistent with the 1986 Wetland Delineation Manual. This wetland is located adjacent to recently constructed Juniper Street and East of HWY 59 in Foley, Baldwin County, Alabama. Coordinates are 30.365243,-87.678018.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. N/A, the wetland is not connected to a TNW, interstate water or territorial seas; however, the closest TNW is the Bon Secour River located approximately four straight-line miles southwest of the review area.⁶

Describe aquatic resources and features within the review area that were determined to be non-jurisdictional because they do not meet one or more categories of waters of the United States under the pre-2015 regulatory regime consistent with the Supreme Court's decision in *Sackett* (e.g., tributaries that are non-relatively permanent waters; non-tidal wetlands that do not have a continuous surface connection to a jurisdictional water).

The review area is a 0.83-acre portion of an approximately 21.54-acre parcel. This 0.83-acre wetland area features soils, hydrology and vegetation consistent with the 1986 Wetland Delineation Manual. This wetland is located adjacent to Juniper Street and East of HWY 59 in Foley, Baldwin County, Alabama. Coordinates are 30.365243, -87.678018.

At one time the wetland connection continued off-site via ephemeral drainages in the northeast corner and in the southwest corner of the parcel; however these ephemeral drainages were filled during the recent construction of South Juniper Street. The filling of the ephemeral drainages severed the surface connection to any potential downstream waters. Culverts were not installed in the southwest end of the wetland to allow for a potential continuous surface water connection. The northeast end of the wetland features an ephemeral drain that was filled, severing the potential culvert connection under South Juniper Street. The wetland is completely surrounded by uplands with no drainage feature leaving the wetland. For all of these reasons, the wetland lacks a continuous surface connection to a TNW, territorial seas, interstate water, relatively permanent tributary or impoundment of a jurisdictional water and is not a jurisdictional water of the U.S.
