MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ SAM-2024-00841-MH9, MFR #1 of #1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

Wetland – 3.5 acres, palustrine forested wetland; non-adjacent; non-jurisdictional.

3. REVIEW AREA. The review area is a 9.98-acre undeveloped, forested parcel located in Tuscaloosa, Tuscaloosa County, Alabama. The center coordinates are 33.186235, -87.604348.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The closest TNW is the Black Warrior River located approximately 4.25 miles south of the review area. The Black Warrior River is on the Mobile District's Section 10 waters list.⁶

⁶ This MFR should not be used to complete a new stand-alone TNW determination. A stand-alone TNW determination for a water that is not subject to Section 9 or 10 of the Rivers and Harbors Act of 1899 (RHA) is completed independently of a request for an AJD. A stand-alone TNW determination is conducted for a specific segment of river or stream or other type of waterbody, such as a lake, where upstream or downstream limits or lake borders are established.

5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS

The 3.5-acre wetland abuts a culvert, which conveys water into an unnamed tributary southeast of the review area, which flows 1,200 feet into a culvert under Fosters Ferry Road and into a channel that extends south into a large wetland that connects to the Black Warrior River south of Interstate 20.

The wetland in the review area encompasses 3.5 acres and is centered at 33.186495, -87.604279. This wetland is surrounded by uplands. It abuts a culvert that extends to a non-relatively permanent tributary outside of the review area (flow regime rationale documentation located in the administrative record). The wetland does not abut a TNW, territorial seas, interstate water, relatively permanent tributary or jurisdictional impoundment; therefore, it does not have a continuous surface connection to a requisite water and is not jurisdictional.
