MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 598 U.S. 651 (2023), SAM-2024-00958-LHL, MFR #1 of #1²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),5 the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

- 3. REVIEW AREA. The review area is a triangular shaped commercial property measuring 4.0 acres in size. The site is bounded by Jarvis Drive to the north and is bounded by two railroad spurs to the east and west. Specifically, the site is located at 30.748656, -86.069078; in Section 44, Township 3 South, Range 4 West, Chickasaw, Mobile County, Alabama. The attached figures depict the 4-acre review area.
- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. The nearest TNW is Hogg Bayou which is on the Mobile District's Section 10 waters list.

A 0.05-acre wetland was identified in the review area at approximate latitude 30.748422, longitude -88.068629. It is assumed this area was excavated during construction of the commercial buildings either in the 1960s or 1980s either for borrow material or detention. The wetland is a depressional feature that is surrounded by uplands with no stream or channel flowing into or out of the wetland to connect it to any downstream waters. Soils outside of the wetland and throughout the site consist of the Urban Land soil series and display the effects from construction on the subject area in 1966. Soil samples taken outside of the wetland by the applicant's agent show a sandy texture with no hydric features. LiDAR data provided as an attachment shows the wetland is surrounded by uplands with no channels flowing into or out of the wetland. Because the wetland is a depressional area surrounded by uplands and no channel flowing out of it, the wetland does not have a continuous surface connection to a TNW, territorial sea, interstate water, relatively permanent tributary, or a jurisdictional impoundment; therefore, the wetland is not jurisdictional.
