MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime  
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322  
(2023),<sup>1</sup> SAM-2025-00154-AGK; MFR #1 of 1<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States,'" as

amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

3. REVIEW AREA. The review area is an approximate 17.5 acre tract located in Boaz, Etowah County, Alabama. The center of the review area is latitude 34.165431, longitude -86.144837, and is located in the Upper Short Creek 12-digit hydrologic unit code (HUC 060300010802) and the Carroll Branch – Clear Creek 12-digit hydrologic unit code (HUC 0031601110103). The imbedded and attached figures depict the review area.

4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. Stream 1.1 and Stream 1.2 are not connected to a TNW, interstate water or territorial seas.<sup>6</sup>

Stream 1.1 is an approximately 248-foot-long by 3.7-foot-wide non-RPW centered at 34.165106°, -86.145010°. The applicant documented there was no flow and no obvious flow conditions, the soils were not hydric, no leaf litter was present within the channel, and channel contained fibrous upland plant roots. The applicant documented stream characteristics and flow regime on a North Carolina Department of Water Quality Stream Identification Form Version 4.11, which reported a total of 7.25 points. Stream 1.1 displays non-relatively permanent flow in response to precipitation throughout its length. Stream 1.1 is depicted in the figure attached.

Stream 1.2 is an approximately 265-foot-long by 2-foot-wide non-RPW centered at 34.164548°, -86.145278°. The applicant documented there was no flow and no obvious flow conditions, the soils were not hydric, no leaf litter was present within the channel, and channel contained fibrous upland plant roots. The applicant documented stream characteristics and flow regime on a North Carolina Department of Water Quality Stream Identification Form Version 4.11, which reported a total of 5.5 points. Stream 1.2 displays non-relatively permanent flow in response to precipitation throughout its length. Stream 1.2 is depicted in the figure attached.
